Sir,

Take Notice, that a Meeting of the Council of the County Borough of Cork will be held in the COUNCIL CHAMBER, CITY HALL, ALBERT QUAY, on FRIDAY, the 14th day of MAY, 1920, at 7 o'clock, p.m., for the transaction of the following business:—

1.—To Read the Minutes of last Assembly.

2.—To consider any special matter which the Lord Mayor or Chairman may bring before the Council, including the following motions, notice of which has been given:—

(a) By the Lord Mayor:—“That a deputation of four be appointed to attend at Rome on the occasion of the Beatification of Oliver Plunkett, martyred by the English Government.”

(b) By Councillor O’Rahilly:—“We, the Corporation of Cork, in Council assembled, hereby record the joy and satisfaction of the people of Ireland at the approaching Beatification of the Venerable Oliver Plunkett, the martyred Archbishop of Armagh, who 239 years ago, as the victim of a bogus plot, was seized and deported by the English Forces then in Ireland, and was ‘legally’ murdered as a criminal and a traitor.

We direct that this Resolution be forwarded to the Cardinal Secretary of State, to his Eminence Cardinal Logue, to his Grace Dr. Harty, Archbishop of Cashel, and to his Lordship Dr. Cohalan, Bishop of Cork.”

(c) By Councillor O'Rahilly :—"That we, the Corporation of Cork, hail with joy the approaching Canonisation of Blessed Joan of Arc, who was burned to death at Rouen, in 1431, by the English Army of Occupation, for the crime of trying to free her country; and in common with all Christendom we acclaim her, the young Virgin Martyr, as the Patron Saint of Patriotism.

We hereby direct that copies of this resolution, stamped with the Municipal Seal, be forwarded to the Most Rev. Dr. Cohalan, Bishop of Cork, for transmission to the Cardinal Archbishop of Paris, and to George Gavan Duffy, for transmission to the Municipalities of Paris, Orleans, Rheims, and Rouen, which Cities are most intimately associated with the stainless name of the Deliverer of France."

(d) By Councillor O'Cuill :—"That the name of George's Street be changed to that of Sraíd Oluibhear Pluinceid."

(e) By Councillor O'Cuill :—"That the resolution passed by Council at its meeting on the 8th January, 1915, ordering that the name of Kuno Meyer be expunged from the Roll of Honorary Freeman, be rescinded, and that his name be restored to the Roll."

(f) By Alderman Barry :—"That in future all positions other than those of Tradesmen and Clerical Staff, be filled only by members of the Irish Transport and General Workers' Union, which offers a guarantee that under such a system more efficient co-operation will be obtained."

3.—To consider Correspondence, including the following :—

- (a) Application from Mrs. Aherne, Caretaker of City Hall and Offices, for an increase of salary.
- (b) Like application from Mr. Frank Carroll, Town Clerks Office.
- (c) Like application from Mr. Sean Courtney, Waterworks' Department.
- (d) Like application from Messrs John Kelleher, Joseph O'Keeffe and Denis McAuliffe.
