To ask the Chief Executive o report on parking in the vicinity of Alfred Street, Railway Street and the adjacent section of the Lower Glanmire Road. In particular, on parking pressures affecting businesses in the area, including the need for loading bays, resulting in illegal parking on cycle lanes and a lack of short-term parking for business customers; the current level of parking enforcement in the area; how these pressures will be affected by current and planned commercial and residential development nearby; and if consideration will be given to reviewing parking arrangements, such as 30 -minute parking, the re-introduction of loading bays, and the physical segregation of cycle lanes."

- 8.1 **REDUCE SPEED LIMIT ON RATHCOONEY ROAD**
That Cork City Council reduce the speed limit on the Rathcooney Road and reduce the speed limit on the Rathcooney and Glanmire Road from 80km to 50km.'

- 8.2 INSTALL YELLOW BOXES ON BANDUFF ROAD**
That yellow boxes be placed outside each Estate on the Banduff Road and that a zebra crossing be installed outside Lotamore.’

- 8.3 TAKING IN CHARGE LOTAMORE ESTATE**
Lotamore Housing Estate be taken totally in charge by Cork City Council.’

- 8.4 ZEBRA CROSSING AT RIVERSTOWN COMMUNITY CENTRE**
That Cork City Council make safer the zebra crossing outside the Community Centre, Riverstown, Glanmire.’

- 8.5 PEDESTRIAN CROSSING AT MEADOW PARK**
That Cork City Council would install a pedestrian crossing by the entrance to Meadow Park and Dunnes, Ballyvolane.’

- 8.6 REGENERATION WORKS IN THE GLEN**
That Cork City Council would complete the regeneration and replacement of fascia, soffits and guttering on all the houses in the Glen, in particular Arderin Way and Comeragh Park, that were not done because funding ran out during the regeneration works six years ago.’

- 8.7 OLD YOUGHAL ROAD UNDER CMATS**
That Cork City Council will report on the nature of commuter pedestrian works planned for the Old Youghal Road under CMATS and that these will include traffic calming and pedestrian priority measures from the pedestrian entrance to Mourne Avenue crossing to Harrington Square, public realm and pedestrian improvements at Dillon’s Cross, and pedestrian crossing measures from the pedestrian entrance to Murmont to the bus stop opposite, Mayfield sports complex, community school, health centre, etc.’

- 8.8 REPLACE VANDALISED SIGNS AT GLEN RIVER PARK**
That Cork City Council will replace vandalised public information signs at the Glen River Park and include in these, measures to improve the perception of public safety in the park, such as Garda and City Council warnings and advice on how to report problems in the park.’

- 8.9 RESURFACE OLD YOUGHAL ROAD THROUGH TO SUMMERHILL NORTH**
That Cork City Council fully resurface Old Youghal Road with particular attention paid from The Three Horse Shoes, into Dillons Cross through St. Luke’s and down onto Summerhill North and include it in the 2020 plan for resurfacing.’

- 8.10 REINSTATE ROAD MARKINGS IN MERVUE ESTATES, BALLYVOLANE**
That the road markings throughout the Mervue Estates be repainted to help with traffic calming and allow drivers to stay on the correct side of the road.’

8.11 TREE TRIMMING AT MEADOWBROOK ESTATE

That Cork City Council carry out tree trimming in the Meadowbrook Estate, with particular attention to the trees shielding the R639 road. These trees are overgrown, and the houses are at risk should we have any bad weather this winter.’

8.12 RESURFACE SILVERCOURT, SILVERSPRINGS

That Cork City Council immediately resurface Silvercourt, Silversprings as a matter of urgency.’

8.13 FLOODING AT JOHN BARLEYCORN BRIDGE, GLANMIRE

‘That Cork City Council install a permanent solution to the ever present flooding that occurs at the John Barleycorn Bridge, Riverstown, Glanmire and to apply for a road closure if necessary to solve this problem once and for all.’

8.14 TREES AT BROOKVILLE ESTATE, GLANMIRE

That Cork City Council make safe the dangerous trees at the entrance to the Brookville Estate, Riverstown, Glanmire.’

8.15 RESURFACING WORKS AT HAZELWOOD, GLANMIRE

‘That Cork City Council give me an update please on the resurfacing works to be carried out in the Riverview and Crestfield Downs Estates in Hazelwood, Glanmire.’

8.16 YELLOW BOX AT BANDUFF ROAD AND DUBLIN HILL

‘That Cork City Council paint yellow boxes outside the estate on the Banduff Road and all estates on Dublin hill.’

8.17 REDUCE SPEED LIMIT ON RATHCOONEY, BALLYVOLANE AND BANDUFF ROADS

‘That Cork City Council reduce the speed limit on the Rathcooney, Ballyvolane Road and Banduff Road.’

8.18 TRAFFIC CALMING MEASURES AT ASHMOUNT ESTATE

‘That Cork City Council would put in place traffic calming measures on the main road through Ashmount Estate. This is the main road through Ashmount and many cars use this road on a daily basis. Vehicles can be seen every day travelling at high speed on this road on a regular basis and this is a very serious public safety hazard given the large number of residents and particularly children living in this area.’

8.19 PLAY AREA AT ASHMOUNT ESTATE

‘That Cork City Council would refurbish the fenced in area in the centre of Ashmount Estate and put in place a playground, a basketball court or some form of play area for the children living in this area. This facility used to be the responsibility of Cork County Council but since the boundary extension this facility is now the responsibility of Cork City Council and there is a significant deficit of play areas for young children in this area.’

8.20 PATH AT PARK COURT/MEELICK PARK

That Cork City Council build a path that allows residents from Park Court/Meelick Park to gain access to bus on the North Ring Road without walking through a mud path that can be overgrown.’

9.1 PUBLIC SAFETY AT ST LUKE'S CROSS

That Cork City Council in the interest of public safety install traffic lights and a pedestrian crossing at St Luke's Cross junction.’

9.2 PEDESTRIAN CROSSING ON BALLYHOOLEY ROAD

In order to compliment the new road development on Ballyhooly Road, that Cork City Council put in place a Pedestrian Crossing on Ballyhooly Road adjacent to the Bus Stop near the former Keatings Furniture premises.’

9.3 RIGHT OF WAY TO BELGRAVE PLACE OFF WELLINGTON ROAD

That Cork City Council commence the process of extinguishing the right of way to Belgrave Place off Wellington Road. The property owners have consented to refurbish the car park, repair and install new perimeter railings which have been damaged over time, install wheelchair access to the properties and oversee the security of this area which has been an area of increased levels of serious anti social behaviour.

9.4 BOARDWALK ON ST. PATRICK'S QUAY

That Cork City Council would put plans in place to put in place a boardwalk on St Patrick's Quay similar to Lapps Quay in order to link up with the new Mary Elmes footbridge and the soon to be developed M Hotel on Patricks Quay. This would significantly enhance the whole streetscape of Patrick's Quay and attract new businesses into this area, increasing footfall as well as enhancing existing businesses as part of the successful development of the Victorian Quarter.’
