6. **QUESTION TIME**

6.1 **CUTS OF GRASS AND LITTER PICKINGS BY CORK CITY COUNCIL**

Please inform council how many cuts of grass have been given to each individual park throughout the City and how many litter pickings of every park that has been taken in charge by Cork City Council has carried out for the years 2015, 2016, 2017 & 2018 and please name all parks?

**REPLY**

Individual parks with lawn/open space areas and grass verges (taken-in-charge since 1963), can range in size from ten housing units to in excess of one hundred units. The recording of frequency of mowing and litter picking of these individual parks/open space areas is not undertaken as it would require considerable additional resources to map and log. In general, estates taken-in-charge, receive a minimum of two mowings per year, litter is collected as required and in most estates these operations are carried out in partnership with local residents. Tree planting and maintenance in all estates take-in-charge is undertaken by the City Council. Landscape improvements and seasonal floral decorations, requested by resident associations are carried out as resources allow.

“Can Cork City Council clarify on what rules are advised to residents of the “Family Hub” in Cork that must be complied with e.g. visiting times, signing in/out after reports from family hubs in Dublin reported extremely harsh rules?”

**REPLY**

All residents of the Family Hub are required to sign up to a Family Code of Conduct when they become residents. The Member will understand that there needs to be such a Code in order to maintain health and safety and protect all residents in the Family Hub, such a Code is essential for the safe running of such a facility.

The Code is not considered unreasonable and the Council is not aware of any complaints with regard to the facility or the internal operational arrangements with residents. Residents and families in the facility are particular with regard to privacy and more so at such a sensitive stage in their family lives. The Family Hub is working very well and is a welcome addition in the City Council’s response to the homelessness issue in Cork City.

Should the Member wish to visit the facility at any stage to review matters, I will be happy to make appropriate arrangements in this regard.

6.4 **CORK LIMESTONE**

In response to the following question submitted by Comhairleoir M. O’Sullivan, a written reply was circulated as outlined below:-

“Can Cork City Council explain why no report thus far has been commissioned, despite numerous motions relating to the quantity and feasibility of Cork limestone, and why the council continues to rely on Chinese granite despite having no real data as to what Cork limestone is available for use?”

**REPLY**

A preliminary report has been completed by the Environment & Recreation Directorate in Sept 2018. This preliminary report has identified the location of the limestone (and various other items such as stone plaques, an old bridge, a stone horse drinking trough, an old newsstand) in various City Council depots (Kinsale Road Landfill and Civic Amenity Site/Recycling Centre, Mahon Depot and Fitzgerald’s Park). A copy of the report will be circulated to all members shortly.

The next phase is to determine the exact quantities of the limestone (from old City Council buildings such as the Eglantine baths) in terms of tonnage and type (columns, lintels, walls etc) and perhaps monetary value. Final phase is to determine if there is potential for re-use

in future projects, either as straight swops or if specific machining of the limestone is required. Resource constraints will determine the timing and level of detail of the next phase.

2 House Purchase Loans were approved in January 2018 before the introduction of the RIHL. 1 House Purchase Loan was drawn down in September 2018. This was a House Purchase loan that had been approved in 2017.

17 Rebuilding Ireland Home Loans have been approved and are pending drawdown.

Please note that 18 additional Rebuilding Ireland Home Loan Applications are to be reviewed by the Credit Control Group.

## 6.8 **PUBLIC, PRIVATE AND AFFORDABLE HOUSING IN BUDGET 2019**

In response to the following question submitted by Comhairleoir M. Nugent, a written reply was circulated as outlined below:-

Can the CE report if there were any measures in Budge 2019 that would assist in the provision of public, private and affordable housing? Is there now an actual affordable housing scheme in place and have any sites in Cork City been identified for such?

## **REPLY**

Budget 2019 announcements relating to Housing contained some steps to stimulate and assist in the provision of housing which are welcome. Announcements made by Government were:

- A commitment to a package of measures, with a particular focus on the development of social and affordable housing. This includes the contribution of €1.25 billion towards the construction, acquisition and leasing of 10,000 new social homes in 2019 and the creation of the Serviced Sites Fund to help local authorities deliver 6,000 affordable homes.
- The Government has also announced a further allocation of €121 million to the Housing Assistance Payment (HAP) scheme to provide an additional 16,760 new tenancies in 2019.
- The easing of the tax burden on residential landlords through the restoration of the 100% tax deduction for interest expenses incurred on loans used to purchase, improve or repair residential property for rental purposes.
- A commitment not to increase in the current rates of stamp duty.

As various items of Budget 2019 related legislation are still progressing through the Oireachtas it will be some weeks yet before the Council receives more specific guidance and circulars from the Department of Housing Planning & local Government (DHPLG) with respect to 2019. This information can be made available to Members and the public when to hand.

The Council has identified sites for housing on the Old Whitechurch Road, Boherboy Road and Kilmore Road Lower/Churchfield Road which it considers suitable for funding under two initiatives, the LIHAF (Local Infrastructure Housing Activation Fund) in the former and the Serviced Sites Fund in the latter two sites. The Council's Housing Capital unit is progressing with the design and implementation of schemes on these sites. A primary criterion for both these DHPLG funding initiatives is the affordability of homes made available to the market.

**REPLY**

The Mahon Local Area Plan contained a number of objectives for the Avenue De Rennes area, including seeking the redevelopment of vacant and underutilised sites to create an attractive high street for Mahon and a physical focus for the community; and enhancing key streets to ensure that they offer safe and attractive environments and encourage walking and cycling.

Recent actions to achieve these objectives are focusing on tackling dereliction and the complex land ownership issues that pertain to the vacant and derelict sites. The Lakelands Tavern site has been placed on the Derelict Sites Register in 2018 and a further site on Skehard Road is also being considered with a view to possible placement on the Register. Any site placed on the Derelict Sites Register in 2018 will be liable for a levy from 2019.

Cork City Council will continue to engage with the owners of these sites with a view to bringing forward redevelopment which would meet the above Local Area Plan objectives. Compulsory acquisition powers can be brought into use where needed to support the comprehensive redevelopment of the area, and establish clear title to lands to facilitate development.

The City Council is in the process of acquiring the former Health Centre from the HSE but this transaction has yet to be completed. It is expected that closing will be reached prior to Christmas. No final decision has been reached on the future use of the building when brought into Council ownership but a number of existing social and community uses are being considered that meet with local need and provide the best opportunity to realize the wider regeneration of the Avenue De Rennes area.

“Could the Chief Executive give an update and details with regards to the ongoing concerns and complaints raised by residents regarding unoccupied house at 8 Avenue De Rennes.

- a) Has Cork City Council received complaints from residents of the neighbouring property, which outlined what they have been enduring with regards to ongoing problems and concerns since this property became idle on the death of previous tenant in 2016.
- b) Since the original tenant died in November 2016 how many times have staff from the housing dept of Cork City Council visited the house at 8 Avenue De Rennes.
- c) Has the housing dept of Cork City Council without appointment made visited the house at 8 Avenue De Rennes and was there anyone present at the said property and who where they and give details of time, dates of the visits.

- d) Has the housing dept of Cork City Council been in contact with the former tenant family?
- e) Has the housing dept of Cork City Council gained access to the property and carried out an inspection of the entire property, for severe dampness due to lack of heating, poor and unkept condition of back and front garden, severe lack of repairs to chutes, fascias and soffits, is electricity on and connected.
- f) Can housing dept of Cork City Council verify that a member of the deceased tenant's family is currently claiming to be living at 8 Avenue De Rennes?
- g) Who is claiming to be the tenant at 8 Avenue De Rennes and has housing dept of Cork City Council verified that the claimant is not residing elsewhere.
- h) What is the housing dept of Cork City Council going to do to resolve the ongoing concern of residents?"

**REPLY**

The property in question is the subject of a City Council tenancy.

- a) I can confirm that Cork City Council has received complaints in relation to this property. The City Council, for security & privacy reasons, cannot comment on the nature of these complaints.
- b) The current Executive Housing Officer (EHO) has called to the property on eight occasions since the most recent complaint, which was received in September 2017.
- c) Yes the City Council conducted unscheduled visits and details of these visits are a matter between the City Council & the tenant.
- d) The City Council, for security & privacy reasons, cannot comment on this question.
- e) Yes. Details of this inspection are a matter between the City Council and the tenant.
- f) The property is the subject of a City Council tenancy.
- g) See response to (f) above.
- h) The City Council can confirm that standard procedure is being followed with regard to the tenancy.

**AGAINST:** Comhairleoirí T. Tynan, J. Kavanagh, F. Ryan, L. O’Donnell, M. O’Sullivan, K. McCarthy, D. Cahill, P.J. Hourican. (8)

**ABSTAIN:** Comhairleoirí J. Sheehan, Leas Ard-Mhéara T. Moloney.

As those voting in favour of the report was greater than those voting against, An Leas Ard-Mhéara declared the vote carried and the report of the Director of Services approved.

The report of the Director of Services stated that the closure of the Marina to vehicular traffic, initially at weekends, is one of the high level goals identified within the Environment Directorate Marina Master Plan. However, this is subject to collaboration with both the Environment Directorate and the Roads and Transportation Directorate on the implications for traffic on adjoining roads if this closure were to be implemented.

Marina Park is included in the Council's application for URDF (Urban Regeneration Development Fund) funding. The Marina itself is included for enhancement works to facilitate pedestrians and cyclists. The Environment Directorate have advised that in the event of URDF funding being secured, a traffic survey will be undertaken in advance of any enhancement works to establish if it is feasible to close the Marina to vehicular traffic as proposed in The Marina Park Master Plan.

### **SUSPENSION OF STANDING ORDERS**

On the proposal of Comhairleoir T. Fitzgerald, seconded by Comhairleoir T. Gould, An Chomhairle agreed to suspend Standing Orders to allow the meeting to continue after 8 p.m.

#### 10.4 **RELAUNCH OF CORK CITY ORBITAL ROUTE**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

'That the Cork City orbital route be relaunched as part of the strategy to encourage motorists to avoid the core city centre streets whenever possible.'

(Proposer: Cllr. T. O'Driscoll 18/242)

The report of the Director of Services stated that the Cork City Orbital route was introduced several years ago to make it easier for motorists to find their way to and from major national and regional routes and to access parking in the city centre. Over the years a number of schemes have been constructed/implemented in the city and signage has been altered/rationalised to coincide with the implementation of these schemes. Also since the introduction of the Cork City Orbital route, technology has advanced so much so that details on routes throughout the city centre can now be obtained from any mobile device or satellite navigation system.

Ongoing improvements will be made by way of improvement schemes and further general road signage upgrades.

#### 10.5 **CHILDREN AT PLAY SIGN AT UPPER DOYLE ROAD, TURNERS CROSS**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council erect a Children at play sign at Upper Doyle Road, Turners Cross.’

(Proposer: Cllr. F. Kerins 18/251)

The report of the Director of Services stated that the request to erect a “Children at Play” sign at Upper Doyle Road, Turners Cross will be assessed.

If deemed suitable, it will be added to the list of requests for signage to be provided, subject to funding being available.

10.6 **TRAFFIC CALMING MEASURES AT O’MAHONEY’S AVENUE, ST. LUKE’S**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That appropriate traffic calming measures be examined and implemented on O’Mahoney’s Avenue, St. Luke’s. The street is being used as a shortcut by a great number of drivers and poses a threat to the health and safety of resident and pedestrians. Residents’ vehicles have also been damaged by speeding motorists.’

(Proposer: Cllr. S. Cunningham 18/257)

The report of the Director of Services stated that traffic calming measures were installed on O’Mahony’s Avenue some years ago. The provision of additional traffic calming measures for O’Mahony’s Avenue is on the list of requests for such works and will be put forward for the consideration of Ward Members to be included in the next Roads Programme.

10.7 **ROAD SIGNAGE AT O’MAHONEY’S AVENUE, ST. LUKE’S**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That road signage be erected on O’Mahoney’s Avenue, St. Luke’s to inform road users that a right-hand turn through Mayfield, Montenotte and St. Luke’s Cross is not permitted. Such signage was removed in the past and should be re-installed.’

(Proposer: Cllr. S. Cunningham 18/258)

The report of the Director of Services stated that O’Mahony’s Avenue will be assessed to determine type and location of signage required.

If deemed suitable, it will be added to the list of requests for signage to be provided, subject to funding being available.

10.8 **STEPS AT BLAIR’S HILL, SUNDAY’S WELL**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council survey Blair’s Hill, Sunday’s Well to determine if steps there can be gated to enhance community safety on a schedule agreeable to local residents.’

(Proposer: Cllr. M. Nugent 18/259)

The report of the Director of Services stated that a report will be prepared to assess the feasibility of gating this laneway. When this report is completed this will be submitted for consideration to the next North-West Ward meeting.

10.9 **PEDESTRIAN CROSSING AT THE FLOWER SHOP ON TRAMORE ROAD**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That City Council would seriously consider moving the pedestrian crossing at the Flower shop on Tramore Road back in a few meters from the roundabout as its too close to the roundabout and pedestrians are in huge danger of being knocked down from drivers who only get sight of this crossing at the last minute when turning onto Tramore Road from Togher Road.’

(Proposer: Cllr. H. Cremin 18/245)

The report of the Director of Services stated that the pedestrian crossing at the Flower Shop on Tramore Road will be assessed to determine the extent of the problems that exist there and identify any possible mitigation measures that could be provided at that location.

If deemed appropriate, the measures will be put forward for consideration to be included in the Roads Programme and will be undertaken, subject to funding being available.

10.10 **IMPROVEMENTS AT PALACEANNE LAWN**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

- (I) That Cork City Council repaint the double yellow lines at the entrance of Palaceanne.
- (II) That we C.P.O the lands as previously agreed to improve the sight lines and install a footpath.
- (III) Ensure Traffic Wardens maintain clearways to facilitate bus collections.’

(Proposer: Cllr. S. Martin 18/249)

The report of the Director of Services stated that:-

- (I) The request to renew the painting of the double yellow lines at the entrance of Palaceanne will be added to the Roads Painting programme and undertaken subject to suitable weather conditions.
- (II) The CPO of the remaining gardens at the Palaceanne Lawn junction will be progressed in the coming years as part of the overall upgrade works on the South Douglas Rd. The project is recommended by the South East Strategic Transport Corridor Study with funding provided by the NTA.

- (III) The Traffic Warden Service will be requested to pay additional attention to Palaceanne in order to deter any illegal parking incidents in the area.

10.11 **TRAFFIC CALMING MEASURES AT O'MAHONY'S AVENUE, ST. LUKE'S**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

'That Cork City Council put in place suitable Traffic Calming measures in O'Mahony's Avenue off St. Luke's Cross. There is an ongoing problem with traffic speeding up and down this narrow hill which also has a primary school located halfway up the hill not to mention the local residents who have had their cars damaged by speeding traffic on this narrow hill.

Can Cork Council:-

- a. Put in place a 30km/hr speed limit on this road.
- b. Erect prominent signage asking motorists to slow down and highlight the fact that there are children at play in the local school.
- c. Put in place at least two narrow speed ramps on the hill which would definitely help to slow down traffic. They would have to be narrow so as not to adversely affect the on street parking used by the residents.'

(Proposer: Cllr. J. Kavanagh 18/261)

The report of the Director of Services stated that:-

- a. The feasibility of reducing the speed limit on O'Mahony's Avenue off St. Luke's Cross will be explored. A reduced speed limit of 30km/h can only be introduced through the making of a Special Speed Limit Bye-Law.
- b. O'Mahony's Avenue will be assessed to determine the type and location of signage required. If deemed suitable, it will be added to the list of requests for signage to be provided, subject to funding being available.
- c. Traffic Calming measures were installed on O'Mahony's Avenue some years ago. The request for additional traffic calming measures for O'Mahony's Avenue is on the list of requests for such works and will be put forward for the consideration of Ward Members when formulating the next Traffic Calming Programme.

10.12 **RESURFACE WESTSIDE ESTATE, TOGHER**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-



‘That Cork City Council resurface the roads in Westside Estate, Togher, as a matter of urgency and that the state be examined and any potholes should be filled in as a temporary measure until the full resurfacing is complete.’

(Proposer: Cllr. F. Dennehy 18/267)

The report of the Director of Services stated that Westside Estate had been assessed but was not included in the 2018 road resurfacing programme and the area will be considered again for the 2019 road resurfacing programme.

In relation to current potholes, Westside will be inspected for any immediate work requirements.

10.13 **TENT CAMP ON PATRICK’S QUAY**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council does not move to evict tenants at the homeless tent camp on Patrick’s Quay until long term accommodation can be sourced as per the “Housing First” model of addressing long term homelessness and the issues that come hand in hand with it.’

(Proposer: Cllr. F. Ryan 18/275)

The report of the Director of Services stated that in accordance with the provisions of the relevant legislation, notice was issued to the occupants of the temporary dwellings at the above location requiring that the temporary dwellings be removed and the area vacated. The Council Housing Directorate and other services providers have engaged extensively in relation to the available emergency accommodation services and a number of people have availed of that service. The area is not suitable for the erection of temporary dwellings and it is necessary that it be vacated as required.

10.14 **30KM/H SPEED LIMIT ON MAHONY’S AVENUE**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council would introduce a 30km/h Speed limit on Mahony’s Avenue between Lower Glanmire Road and St. Luke’s Cross which is being used as a short cut by traffic on the one way Lower Road to return to the city centre while avoiding the quays. Noting that Mahony’s Avenue is the location of a popular primary school and is purely residential in character that the Council would give urgent consideration to introducing this reduced speed limit and institute whatever other measures are required to deter its use as a rat-run.’

(Proposer: Cllr. T. Tynan 18/277)

The report of the Director of Services stated that the feasibility of reducing the speed limit on O’Mahony’s Avenue off St. Luke’s Cross will be explored. A reduced speed limit of 30 km/h can only be introduced through the making of a Special Speed Limit Bye-Law.

10.15 **FOOTPATH/FOOTWAY SURVEY**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council would carry out footpath/footway survey, compile a report on the condition, standard include the health and safety for pedestrians and residents in the following streets; St. Michaels Lawn, St. Michaels Close, Ballinure Avenue, Ballinure Cottages, Ballinure Lawn, Ballinure Place, Ballinure Crescent, Ballinure Road, Delwood Grove, Ashwood, Mahon Drive, Mahon Crescent, Mahon Park, Loughmahon Road, Loughmahon Avenue, Loughmahon Court, Loughmahon Drive, Loughmahon Close, The Paddock, Lakeland Crescent, Lakeland Avenue, Ravensdale Road, Ravensdale Avenue, Ravensdale Close, Castle Park, Island View, Helm Close, Ringcroft the View, Ringmahon Road, Ringmahon Avenue, Ringmahon Close, Limes Avenue, Castle Close, Lake Lawn, Skehard Road, Castle Meadows, Rockwood, Ferney Road, Ferney Close, Ferney Grove, Beechwood Road, Beechwood Close, Beechwood Court, Nutley Road, Nutley Avenue, Gate Lodge, Meadow Grove Estate, Ballinsheen Court, Ballinsheen Mews, Convent Road, Rope Walk.’

(Proposer: Cllr. C. O’Leary 18/280)

The report of the Director of services stated that targeted footpath surveys are currently underway based on requests received by Elected Members and the public through the Customer Requests Management (CRM) system. Localised repairs are ongoing and will continue to be carried out as resources allow. Essential works are and will be prioritised. Footpath repair budget has been limited over the past number of years due to budgetary constraints nationally but it is hoped that a more comprehensive footpath programme could be rolled out as this situation changes.

On the proposal of Comhairleoir P. Dineen, seconded by Comhairleoir K. McCarthy, An Chomhairle further agreed to adopt the following Resolution:-

“Resolved that, pursuant to the provision of Section 6 of the Housing (Miscellaneous Provisions) Act, 1992, a loan facility not exceeding €246,845 be granted to Co-operative Housing Ireland Society Ltd. for the provision of 6 no. units of accommodation at Block B, Grenville Court, Grenville Place, Cork, subject to the terms of the Capital Advance Leasing Facility Scheme.”

11.5 **GALTAN CLG – ACCOMMODATION AT LOWER GLANMIRE ROAD, CORK**

“Resolved that, pursuant to the provision of Section 6 of the Housing (Miscellaneous Provisions) Act, 1992, a loan facility not exceeding €3,976 be granted to Túath Housing Association CLG for the acquisition of 1 unit of accommodation at 27 Mount Farran, Assumption Road, Blackpool, Cork, subject to the terms of the Capital Advance Leasing Facility Scheme.”

The report of the Director of Services stated that the City Council is preparing a submission for the Department of Housing, Planning & Local Government to seek funding to develop infill housing at the site.

11.11 **INFILL HOUSING AT CUSHING PLACE**

The report of the Director of Services stated that the City Architects Department is currently advancing plans for infill housing at this location. Stage 1 Departmental approval has been received and Stage 2 submission is being prepared.

11.12 **INFILL HOUSING AT LAGAN GROVE “TARRY PATH”**

An Chomhairle considered and approved the report of the Director of Services, Housing and Community Services dated 11<sup>th</sup> October 2018 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council construct infill public housing on the existing Lagan Grove pathway to the South of Lagan Grove, and on the pathway known locally as the “Tarry Path” to the rear of Mount Brosna, Avonmore Park and Glenamoy Lawn.’

(Proposer: Cllr. T. Tynan 18/238)

The report of the Director of Services stated that the City Architects Department is currently advancing plans for infill housing at this location. The Housing and Community Directorate will facilitate a meeting with local ward members to examine the plans in due course.

11.13 **LAND NORTH OF MAYFIELD COMMUNITY SCHOOL**

‘That Cork City Council report on the services provided and budget available to the Homeless Persons Unit at Drinan St. and the Council’s role in same. Council to clarify if

the unit is to be relocated to a more suitable premises that is fit for purpose in addressing the ever growing numbers of the public needing support.’

(Proposer: Cllr. M. Nugent 18/260)

The report of the Director of Services stated that the Homeless Persons Unit is currently operated on behalf of Cork City Council by the Department of Employment Affairs & Social Protection at its premises at Drinan Street.

The service is currently under review and a City Centre premises is required to locate a new service where a team will be put in place to provide a holistic focus on individual solutions and supports for those who find themselves homeless.

This team will have overall responsibility for the delivery of a central placement service and the provision of information and advice. The budget for the provision of the Homeless Persons Unit for 2018 is €34,000. I will keep members informed of progress in this area.

should request a response from An Garda Síochána with regard to their role in the enforcement of traffic legislation and bylaws in this area. Finally, that this review would also include public consultation with the local Residents Association and residents.'
